The Company has engaged the services of Central Depository Services (India) Limited, ("CDSL") as the Agency to provide e-voting facility.

3. Manner of Casting vote through e-voting:

Shareholders will have an opportunity to cast their votes electronically, either remotely or during the AGM on the business set forth in the AGM Notice. The login credentials and detailed procedure for casting the votes through e-voting shall be made available to the shareholders through email (who have registered their email with the Company) and also the same is made available in the AGM Notice and published in Company's website.
